Violence And Harassment in the Workplace Part II

Harassment Policies – A clear policy towards harassment helps to create a supportive work environment where violence and harassment are not tolerated. The purpose of a harassment policy is to ensure that everyone understands that acts of violence or harassment are considered a serious offence with clear consequences, and to assist and advise those subjected to violence or harassment.

Identifying and Assessing the Hazard – Your HSM contains hazard and risk assessment tools that you can use to determine the nature and extent of any potential problem. You should determine whether you have an unusual or likely risk of harassment or violence. Your HSM provides you with tools for reporting, trending and investigating incidents to help you determine who is at risk and when.

Controlling the Hazard – The likelihood of harassment and violence is reduced when:

- Workers understand the employer's commitment to preventing workplace violence and harassment, and
- Prompt and appropriate response occurs in response to a reported incident of violence or harassment.

Worker and management harassment and violence communication should be included during the orientation, and through on-going education.

Harassment and Violence Procedures – Your HSM contains Safe Work Procedures (SWPs) that outline how your policies actually work. Key elements include:

- Right to assistance and alternatives available (legal recourse)
- Formal reporting and investigation
- Intervention, follow-up and assistance
- Confidentiality and no recrimination against the complaint

Conclusion – Your HSM contains all of the tools required to support your Prevention of Harassment and Violence Program.
